MR. CORBETT: Mr. Kennedy, forgive me, some of that I missed in the middle. Were you able to get all of that?

(The Court Reporter read back the requested material.)

- Q. What do you mean by patrolling the Hudson?
- A. We would track down polluters, we would take samples, collect evidence against polluters and then we would file lawsuits against them. We filed I think over 500 lawsuits against Hudson River polluters.
- Q. You say track down. Under what authority were you tracking down polluters?
 - A. There are two principle statutes that we operated

under. One was 1888 Rivers and Harbor's Act. It was also called the Refuse Act. And it allowed individuals to document pollution and then collect bounties.

And there was a -- the Clean Water Act was another statute that we operated under. And like many of the environmental statutes that were passed after Earth Day 1978 there were 21 statutes passed. And taking the citizens supervisions that allowed individuals who are affected by pollution when the government agencies fail to enforce the law, to step into the shoes of the United States attorney and prosecute that polluter for penalties of over \$30,000 a day for adjunctive relief and then to collect attorneys fees.

- Q. Are you done, Mr. Kennedy? I'm sorry, I don't want to interrupt you. It seems and it appears that you are somewhat of an expert in the Clean Water Act; is that a fair statement?
 - A. Yes.

- Q. You have a very deep understanding of that statute and the laws?
 - A. Yes.
- Q. Is it fair to say you don't have the same depth and understanding of the New York State Election Law?
- MR. SAVINO: Objection, relevance, Your Honor.

- A. What we agreed -- it was a hardship for me to move to California, which I did. I did gratefully out of love, but it was something that at that time my children didn't want to do and that I didn't want to do. And all of us love Bedford and they had grown up there and nobody wanted to move.

So she was very -- she at one point offered to come to New York but that would have meant ending her career which I didn't want her to do. And I said that I would figure out a way to make a living in California until we can move back. And that was our agreement. And I've discussed that agreement with her since and that's our agreement today.

Q. Is Cheryl Hines a co-star of a TV series?

- A. Yeah, she's the -- she's been on many TV series, but her longest, her most identifiable series is Curb Your Enthusiasm.
 - Q. With Larry David?
 - A. Yeah, with Larry David.
 - Q. And when did she start being filmed for Curb Your Enthusiasm?

And there's no convenient place for them to stay that's anywhere nearby. And I'm not in Westchester very much, I'm in New York. And the security detail makes the arrangements for where I stay, which is usually a hotel where they can have rooms next to me.

- Q. Since you announced your run for President, on average for those intervening 15 months how many days per month are you typically on the road campaigning to become our President?
 - A. About 27 days a month.
- Q. So you're available to stay at Croton Lake Road or in
 Los Angeles two-, three-, four days a month?
 - A. Exactly.

- Q. Let's talk about that campaign. When did you announce?
- A. We've already established I'm bad at dates, but I think it was March of 2023.
- Q. And when you announced, for what party did you announce?
 - A. Democrat.

So there were a number of rules like that that were designed to make sure that there was not an authentic election. And then a couple of the, you know, major states where I could have done well were just cancelled all together. The primaries were.

- A. To move to Independent.
 - Q. And where did you actually announce that move?
- 11 A. In Philadelphia.

- Q. Now, you said New York is the place to which you intend to return. I want to drill down on that. For the intent to return, is there a particular part of New York to which you intend to return?
 - A. To Bedford, New York.
 - Q. Why the affinity with Bedford?
- A. I had -- first of all, I raised my kids there. I lived there for most of my adult life or the last -- for almost 40 years. But I was drawn there for a number of reasons. One is the landscapes are very appealing to me. I spent -- there's a writer called Wallace Stegner, who is one of my favorite writers, and he says that we all have a yearning in our hearts for the landscapes of our youth. So that people in western states have a yearning, a permanent ingrained yearning, for big skies or monumental landscapes.

I was raised my first 13 years in northern Virginia on agricultural landscapes of broken field and forest rolling hills, intermittent streams and abundant water and certain wildlife that I developed an attraction to. Those landscapes today are gone, they're all paved over.

But I found when I moved to New York, I was 14 years old after my dad was killed, I spent two years in boarding school at Millbrook, New York, which was a school that had a zoo, and each student had three hours a day to do special

projects. And I trained hawks at that time. Really started aggressively training and hunting with hawks.

2.2

And so I spent three hours a day, seven days a week for two years in the autumn, winter and early spring wandering those landscapes and they -- and that imprinted on me. And the landscapes of Bedford are identical to those landscapes.

And then Bedford has this added advantage which is it's 22 miles from Midtown Manhattan. So you can get into the city to do work, to eat dinner, to have entertainment and still live in this really extraordinary countryside.

There are five blue ribbon trout streams in Bedford.

I don't think there is any city in the country that close to
the city center has five trout streams.

Bedford is 16 miles from Long Island Sound where I started the Long Island Soundkeeper. I had a lobster license that allows me to scuba dive at night there and I trap lobster there. I fish for stripers and blue fish and scup and tautog there.

It's also almost exactly 16 miles from the Hudson where I keep my boat in the marina at /OS /TPHOPBG. I taught my kids to water ski on the Hudson. I go camping there, I go fishing there, I go skiing and have other recreational -- it's 116 miles exactly from Windham and about 112 miles from Hunter Mountain and I take my kids -- I love to ski in the Catskills and I skied up there every weekend.

It's right across the river from Schunemunk Mountain, which is the best ridge line to trap hawks on probably in the country. And I keep my birds. I have friends who I grew up with since I was 14 flying birds and I keep my birds in Goshen across the river. And that's where I usually do hunting, either in Bedford or in Goshen.

For me it has all these extraordinary attributes. I can go on a lot longer, but it's a place that I feel like I have literally everything that I've ever wanted. It feels kind of like Heaven to me.

I had a Reservoir Keeper that we started on the river. A whole project. I had the Hudson Riverkeeper, of course, was on the Hudson, which was my first client and was my client forever in my advocation.

And the third Riverkeeper was the Long Island Sound
Keeper which was started by commercial fishermen on Long Island
Sound. I litigated against virtually every city and town on
Long Island Sound for sewage treatment plants.

I closed the Pelham Bay dump. I closed the Croton

Landfill which was in Westchester County. A lot of the

litigation I did was there. I just feel very, very attached to
the County.

- A. New York City gets its water from three different sources: Two reservoir systems in the Catskills, the Delaware and the Catskill --
